All mail and online voter registration applications or updates must be received by Monday, July 25, 2022 to be effective for the August 2, 2022 Primary Election. Submit changes online at: [www.VoteWA.gov](http://www.VoteWA.gov) or by mail to PO Box 400, Shelton, WA 98584 – must be received by our office by Monday, July 25, 2022 or any other county elections office in Washington State.

After Monday, July 25, 2022, all voter registration applications or updates must be done in-person, at our Voter Center until 8:00 pm on Election Day to be effective for this election. We are located at 411 N 5th St, Shelton, WA 98584 (back of the building off of Pine St.).
